## **ALTERNATE BUS STOP REQUEST**

Our Bus Routing Software assigns a student to a bus stop based on the school of attendance, and home address. Students will be assigned to the nearest bus stop closest to their home that they can walk to without crossing major streets.

If you wish to have your student assigned to an alternate bus stop for reasons including divorce, an exception to a student's assigned bus stop or eligibility; this form will need to be filled out completely and returned to the Transportation Department each school year the exception is requested. The deadline for submitting this form is August 15<sup>th</sup>

Please allow (5) five days for the Transportation Department to determine if an exception <u>can be approved</u>. Please use one form for each student request.

## NOTE: SCHOOL OF CHOICE & IN-DISTRICT TRANSFER STUDENTS are not eligible for transportation.
